Group Chief Executive Officer

Born in 1953, Mr. Perissinotto joined Assicurazioni Generali in 1979 after graduating from Trieste's University with a Business Management degree. From 1979-1989 he worked in UK, Belgium and United States in the Investment Department and in 1989 he became responsible for the Foreign Investments at the parent company in Italy (Trieste).

From 1993 on, he managed the Corporate Finance Department. In 1996 he was appointed Deputy General Manager and then, in 1998, General Manager of Assicurazioni Generali, supervising Investments, Accounting and Taxes, Investor Relations.

In 2001 he was appointed Managing Director of Assicurazioni Generali. He is one of the executives responsible for setting the group's overall strategic direction and he is a member of the firm's executive committee.

In 2010 he was appointed Group CEO of Assicurazioni Generali SpA.



Chief Risk Officer

Born in Trieste in 1948, started his professional career in 1967 at Assicurazioni Generali, after his graduation in Economics at the University of Trieste. He is a CFA (Chartered Financial Analyst, Member of the AIMR), AIAF (Financial Analyst, Member of the Italian Association), Financial Consultant approved by the CONSOB Authority.

From 2000 to 2002 CEO of Generali Asset Management SGR S.p.A., then Manager of the Finance Department of Assicurazioni Generali, currently he is Chief Risk Officer of the Generali Group and Head of the Risk & Capital Management Department; Member of the CRO FORUM.

He is also President and Director in several Boards of different Companies (Financial and Banking Area)



Chief Life Actuary

Born in Trieste in 1965. He achieved a degree in Statistical and Actuarial Science in 1989, at the University of Trieste. In 1990 he passed the examination for the Actuarial profession and consequently enrolled as a member in the Actuarial Italian Society.

In 1991 employed in Assicurazioni Generali s.p.a, in the Life Department.

In 2007 he assumed responsibility for Life Department of Assicurazioni Generali, and Project manager of the Variable Annuities assignment.

Salvatore also sits on the Board of two Generali affiliates, Fata in Rome and Generali PanEurope in Dublin.



Chairman and Chief Executive Officer, Generali Investments

Philippe Setbon, a French citizen born in 1965, graduated at the University Paris Dauphine in 1990 and at the Formation Centre for the Financial Analysis (SFAF) in 1993. He started his professional career in 1991 as a Financial Analyst at Barclays Bank Paris. From 1993 to 2001 he was European Equity Manager, then CEO of Boissy Gestion (AZUR-GMF). In 2001, he became President and CEO of Boissy Gestion.

Mr. Setbon joined Generali in February 2004 as Deputy General Manager and Chief Investment Officer of the French asset management subsidiary, Generali Investments France, where he is currently Chief Executive Officer. He is also Chairman of Generali Investments SICAV (Luxembourg) and of Supervisory Board Generali Investments Deutschland. He is Vice Chairman of Generali Fund Management and Generali Investments SGR. He has been appointed Board Member of Guotai AMC in 2010.



Chief Executive Officer, Generali Immobiliare

Born in 1961, graduated at the Bocconi University of Milan in 1985 with a degree in Finance and Business Management.

Mr. Scotti joined Generali in September 2007 from Lazard. He was Director and Partner of Lazard & Co SpA, ultimately Head of Lazard Italy Branch and Head of Lazard's European Real Estate Group.

He is the CEO of Generali Immobiliare, Corporate Center Department of Assicurazioni Generali dedicated to the Group Real Estate Asset Class.

Mr. Scotti is the chairman of Generali Immobiliare Italia SGR, the Italian Management company dedicated to Real Estate Funds. He is as well President and CEO of Generali Gestioni Immobiliare SpA, the Italian real estate service company, and Managing director of Generali Properties S.p.A.; he also sits on board of other Generali affiliates dedicated to Real Estate investment.

He also serves on Board that do not belong to the Generali Group which are NTV SpA ("Nuovo Trasporto Viaggiatori") and IEO ("Istituto Europeo di Oncologia").



General Manager and Chief Financial Officer

Born in 1957 in Casarsa della Delizia (Pordenone). He graduated with a Business Management degree, and joined Generali in 1983. He was appointed Deputy General Manager in 2001, General Manager in 2004 and Chief Financial Officer in October 2007.

Within the Company, Mr. Agrusti supervises the Areas of Consolidation and Control, Strategic Planning, Finance, Real Estate, Legal and Corporate Affairs, Enterprise Risk Management, Investor Relations and Group Tax Consulting.

Mr. Agrusti is Chairman of GenertelLife, Generali Investments Italy, and of Generali Immobiliare and is Deputy Chairman of Genagricola and Generali Properties. He also serves on Boards that do not belong to the Generali Group which are RCSMedia Group, Premuda S.p.A., and NTV S.p.A.
