

## Dividend payment 2011 Financial Statements Documents

Disclosure pursuant to Article 84 of CONSOB resolution no. 11971 of 14 May 1999

The Shareholders' Meeting held in Trieste on April 28, 2012 approved – among other things – the Company's Financial Statements as at December 31, 2011 and resolved on the distribution of a gross cash dividend per share of  $\notin$  0.20 for 2011.

The dividend will be payable as from May 24, 2012 through the intermediaries of the Monte Titoli S.p.A. central management system, with detachment of coupon no. 21. Shares will trade ex-dividend as from May 21, 2012 (ex-date).

The holders of shares that have not yet been dematerialized will receive the dividend only after they have surrendered their share certificates to an authorised intermediary for inclusion, in dematerialized form, in the centralized management system.

The minutes of the Shareholders' Meeting will be made available to the public within the legal deadlines.
