



## PRIVACY NOTICE

The purpose of this privacy notice is to explain how, and for what purposes, we use your Personal Data. Please read this privacy notice carefully.

### 1. Which legal entity will use your Personal Data

Assicurazioni Generali S.p.A. will use your Personal Data acting as Data Controller. If you want to contact us, please use the following contact details:

### 2. How we use your Personal Data

The Company will use your Personal Data exclusively for the purposes of properly handling your application, and in order to identify and retrieve your file when necessary.

The Company is entitled to process your Personal Data on the basis of your consent.

### 3. Which Personal Data we use

Only Personal Data strictly necessary for the above-mentioned purposes will be processed. In particular, the Company will process:

- Your name and surname;
- Your date of birth;
- Your home address and/or e-mail address;
- Your bank details, if necessary.

### 4. With whom we share your Personal Data

If your application does not qualify for any compensation payment, your Personal Data will not be shared with anyone.

In case of payment, instead, we may share your Personal Data with other Generali Group companies and external entities - such as banks - exclusively for the purposes of executing the payment. Additionally, your Personal Data might be disclosed to other parties (e. g. other heirs) only if the payment made in your favour is questioned, or in case of misrepresentation or fraud.

## **5. Why the provision of your Personal Data is required**

The provision of your Personal Data is required in order to identify your application and contact you at the end of our investigations.

If you do not provide your Personal Data, we shall not be able to contact you and inform you of the result of our investigations, including payment, if any. Moreover, we shall not be able to retrieve your file if you need additional clarifications or request a review of our search.

## **6. Where we transfer your Personal Data**

Your Personal Data will not be transferred.

## **7. Your rights in respect to your Personal Data**

You can exercise the following rights in respect to your Personal Data:

- Access – you may request access to your Personal Data;
- Rectify – you may ask the Company to correct Personal Data that is inaccurate or incomplete;
- Erase – you may ask the Company to erase Personal Data where one of the following grounds applies:
  - a. Where the Personal Data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
  - b. You withdraw consent on which the processing is based and where there is no other legal ground for the processing;
  - c. You object to automated decision-making and there are no overriding legitimate grounds for the processing, or you object to the processing for direct marketing;
  - d. The Personal Data have been unlawfully processed;
  - e. The Personal Data have to be erased for compliance with legal obligation in Union or Member State law to which the Company is subject;
  - f. The Personal Data have been collected in relation to the offer of information society services.
- Restrict – you may ask the Company to restrict how it processes your Personal Data where one of the following applies:
  - a. You contest the accuracy of your Personal Data, for a period enabling the Company to verify the accuracy of your Personal Data;
  - b. The processing is unlawful and you oppose the erasure of the Personal Data and request the restriction of their use instead;

c. The Company no longer needs the Personal Data for the purposes of the processing, but they are required by you for the establishment, exercise or defense of legal claims;

d. You have objected to processing pursuant to the right to object, pending the verification whether the legitimate grounds for the Company override yours.

- Portability – you may ask the Company to transfer the Personal Data you have provided us to another organization or / and ask to receive your Personal Data in a structured, commonly used and machine readable format.

- Withdrawal of consent – you may withdraw your consent, at any time, for the processing of your Personal Data for which you have provided consent.

Your rights, including the right to object (refer to point 8 below), can be exercised by contacting [pic@generali.com](mailto:pic@generali.com). The request of exercise of rights is free of charge, unless the request is manifestly unfounded or excessive.

## **8. Your right to object to the Processing of your Personal Data**

When the Processing of your Personal Data is based on the legitimate interest, including for direct marketing purposes, you have the right to object to the Processing of your Personal Data and, thus, request the stop of the Processing operations.

## **9. How you can lodge a complaint**
